## I. GUARANTEE AND GOLF CARTS

- A. A final count of players is due one week prior to the outing. The club will allow up to a 10% reduction in this number based on an actual count the day of the outing. This is the number for which you will be financially responsible unless the outing is below the minimum requirement, in which case the minimum will be applied.
- B. The following is also required for all tournaments:
- Golf carts must be used by all players.
  - Walkers or spectators are not allowed.
  - Fivesomes will not be permitted at any time.
  - Soft-spike golf shoes, or tennis shoes are required.

## II. SHOTGUN TOURNAMENTS

- A.) All Shotguns that desire private use of the course must have a 120 minimum guarantee.
- B.) Full shotguns (120+ players) on Mondays and Thursdays will begin promptly at 8:30 a.m. (groups will depart at 8:20, and tee off at 8:30). Full Shotguns on Friday, Saturday, and Sunday will begin at 1:00. We recommend that you post the tournament

start time as ½ hour earlier than scheduled to ensure your players arrive, register, and are ready to start on time. Any players arriving late will be driven out to their assigned holes by club staff.

- C.) **All Shotguns with fewer than 116 players will begin at 9:30am on Mondays and Thursdays or, if scheduling permits, 1:30 Friday, Saturday, and Sunday afternoons. These Shotguns must guarantee 64 green fees. The club will not be able to accommodate groups showing up with more than originally confirmed. The club reserves the right to exclude any “add-on” foursomes the day of the event.**

### **III. BILLING, DEPOSITS, REFUNDS, RAIN DATES**

- A.) **Deposits:** Deposits and signed contracts are required for all golf events. A reserved date is official only after we have received the deposit and contract. A deposit of \$500.00 is required for all full shotguns, \$300.00 for all other outings. **Note: the deposit serves as a security against damages to club property, incorrect meal counts, etc. incurred during your outing. The club will notify the contact listed above the day of the outing should there be any claim against the deposit.**
- B.) **Refunds:** **The first \$50.00 of every deposit is non-refundable to cover processing expenses. The remaining amount is refundable if notice of cancellation is given 30 days prior to the outing date. All outings cancelled due to inclement weather will be issued a full refund. The club may honor a request to reschedule an outing at the discretion of management and the deposit becomes non-refundable thereafter.**
- C.) **Rain Dates:** If play is not possible on the date scheduled (as determined by Easton Country Club), we will do everything possible to schedule a rain date. However, if the weather is only overcast with light rain and the course remains playable, your outing will be expected to play on the scheduled date.
- D.) **Billing:** Payment for the outing is due on the date the event is scheduled. It is preferred that a single check be submitted to cover all expenses related to the tournament and meal service. Credit cards will be accepted with a 2% surcharge. Invoices may be prepared in advance per your request.

### **IV. FOOD AND BEVERAGES**

**No outside food and/or beverages may be brought onto the golf course. This includes any donations made by tournament sponsors. Violators may be subjected to a surcharge.**

- A. **Meal selections** must be submitted one month prior to the day of the event. The actual number to be served is requested 7 days prior to the function. The final number submitted is the number you will be billed for, regardless of any no-shows. **If you are expecting additional guests for dinner who are not playing golf, these people must be included in your final count.**
- B. **No outside food and/or beverages may be brought to the golf course, including any donated items.**
- C. **Coolers are not allowed on the golf course at any time.**

### **V. ALCOHOLIC BEVERAGES**

- A) The Club, in accordance with State law, is solely responsible for the sale and distribution of alcoholic beverages: the club must supply all alcohol. Additionally, State Law defines parking lots as public ways. Therefore no alcohol beverage open container is permitted

in the parking lots at any time. Violators will forfeit golf and dinner privileges and must leave premises.

- B) **The club reserves the right to search any personal carry items to enforce the alcohol policy. This includes golf bags, gift bags, etc .**
- C) It is the responsibility of the Tournament Director to see that all participants abide by the above policies. Those outings in violation may lose their privileges for booking future tournaments.

**VI. PACE OF PLAY AND LIABILITY**

- A.) To properly utilize the course and be considerate of others, we must insist that all players maintain an appropriate pace of play. The Club's rangers have the authority to make specific instructions regarding the pace of play. **Foursomes that cannot keep pace with the group in front may be required to pick up and move ahead.**
- B.) The Club reserves the right to monitor all private functions. Liability for damage to the premises will be charged accordingly. The Club cannot assume responsibility for personal property and equipment brought onto the premises.
- C.) **Golf Carts:** Each person is responsible for any damages occurring on the above date to carts rented to the above group. It is agreed that in signing this form for golf cart rentals, the signatory agrees to:
  - 1. Assume all risks attendant with the operation and thereof including responsibility for any and all damages caused to carts due to negligent use of operation of same.
  - 2. Release and absolve owners of the Club, their employees or agents from any liability for injury to his person or property resulting from the operation of the cart.
  - 3. Indemnify owners of the Club, their employees or agents against any liability to any persons for personal injury or property damage resulting from said operation.
  - 4. Not allow children (under 18 years).
  - 5. Not to drive the golf cart outside the golf course property or in restricted areas.
